The City of Houston (City) Housing and Community Development Department (HCDD) complies with Civil Rights Act requirements.

CITIZEN PARTICIPATION

Through the City's Citizen Participation Plan, HCDD encourages residents to participate in the development of priorities, strategies, and funding allocations related to its planning documents. The City emphasizes the involvement of low- and moderate-income persons, persons with disabilities, members of vulnerable populations, and organizations that serve these residents. Each federal funding source has a separate but similar Citizen Participation Plan, which outlines participation requirements and information about filing a complaint.

ASSISTANCE TO PERSONS WITH DISABILITIES

The City of Houston does not discriminate on the basis of disability for participants, beneficiaries, applicants, or employees, in accordance with Section 504 of the Rehabilitation Act of 1973, which prohibits discrimination in federally assisted programs on the basis of disability (handicapped status). AFFIRMATIVELY FURTHER FAIR HOUSING
